#### TRAFFIC SIGNAL EOUIPMENT EASEMENT AGREEMENT

	THIS TRAFFIC SIGNAL EQUIPMENT EASEMENT AGREEMENT ("Agreement") is made
as of _	, 2025, by COBBLESTONE COMMUNITY DEVELOPMENT DISTRICT,
a local	unit of special purpose government, organized and existing under Chapter 190, Florida Statutes
(the "I	District"), whose address is: c/o Inframark, LLC, 2654 Cypress Ridge Boulevard, Suite 101,
Wesley	y Chapel, Florida 33544 (the "Grantor"), and the STATE OF FLORIDA DEPARTMENT OF
TRAN	SPORTATION, whose post office address is: Post Office Box 1249, Bartow, Florida 33831-1249
(the "F	<b>TDOT"),</b> with reference to the following facts:

- A. Grantor is the owner of certain real property described and depicted on **Exhibit A** attached hereto and incorporated herein by reference (the "Easement Area").
- B. Traffic signal equipment (the "Signal Equipment") is located within the Easement Area, and Grantor desires to grant to the FDOT an easement in, to and over the Easement Area for maintenance, repair and replacement of the Signal Equipment, and the FDOT desires to accept such easement, as more particularly set forth in this Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, the parties agree as follows:

- 1. <u>Recitals: Exhibit.</u> The above recitals are true and correct and, together with the Exhibit attached hereto, are incorporated herein by this reference.
- 2. Grant of Easement. Subject to the terms and conditions of this Agreement, Grantor hereby grants to the FDOT, its successors and assigns, a perpetual, non-exclusive easement (the "Easement") on, over, under, upon and through the Easement Area, for purposes of maintaining, repairing and replacing the existing Signal Equipment. The Easement shall include associated rights of ingress and egress for the FDOT and its contractors over the Easement Area for purposes of exercising the easement rights granted herein. The FDOT shall exercise the Easement in a reasonable manner and in compliance with all applicable laws, statutes, ordinances, rules, codes, regulations, permits and approvals. Any work performed by or on behalf of the FDOT within the Easement Area shall be performed in a good, workmanlike and lien-free manner.
- 3. <u>Maintenance and Repair.</u> Grantor hereby quitclaims to the FDOT all of Grantor's right, title and interest, if any, in and to the Signal Equipment, and the FDOT shall own, maintain, repair and replace the Signal Equipment within the Easement Area, for the purpose for which the Signal Equipment is intended, at the FDOT's sole cost and expense.

- 4. <u>"As-Is".</u> The Easement is granted and conveyed to, and accepted by, the FDOT in "AS IS" condition and without any warranty or representation, express or implied, by Grantor as to the condition or suitability for the FDOT's purposes or otherwise. FDOT acknowledges that the Easement granted herein is subject to all easements, restrictions, reservations and other matters of record affecting title to the Easement.
- 5. <u>Sovereign Immunity.</u> Nothing in this Agreement shall be deemed as a waiver of immunity or limitation of liability of the Grantor to the extent provided by Section 768.28, <u>Florida Statutes.</u> and nothing in this Agreement shall inure to the benefit of any third party for the purpose of allowing any claim which would otherwise be barred under the Doctrine of Sovereign Immunity or by operation of law.
- 6. <u>Covenants Running With the Land: Binding Effect.</u> The rights and burdens created hereby shall constitute covenants running with the land, burdening the Easement Area, binding upon Grantor and its successors in title as to the Easement Area, and binding upon and inuring to the benefit of the FDOT and its successors and assigns (as to which the FDOT lawfully assigns its rights and obligations hereunder).
- 7. <u>Amendment: Waiver.</u> This Agreement may only be amended, modified or terminated by an instrument executed by all parties hereto, or their respective successors or assigns. No waiver of any provision hereof shall be effective unless done so in writing signed by the party entitled to enforce such matter, nor shall any single waiver constitute a waiver of any subsequent obligation.
- 8. <u>Attorneys' Fees.</u> In the event of any dispute arising under this Agreement, the prevailing party in such action shall be entitled, in addition to all other relief granted or awarded by the court, to a judgment for its reasonable attorneys' and paralegals' fees and costs incurred by reason of such action and all costs of mediation, arbitration, suit at both the trial and appellate levels, and any bankruptcy action. This provision shall survive termination of this Agreement.
- 9. <u>Governing Law: Venue.</u> This Agreement shall be governed in accordance with Florida law. Venue for any dispute arising under this Agreement shall lie exclusively in the courts located in Pasco County, Florida. This provision shall survive termination of this Agreement.
- 10. <u>Counterparts.</u> This Agreement may be executed in separate counterparts, each of which shall be deemed an original, and all of which when taken together, shall constitute one and the same instrument.
- 11. <u>Notices.</u> Any notices to be delivered pursuant to this Agreement shall be delivered to the parties at the addresses set forth under such party's signature below. Any party may change its address for notice purposes by delivering written notice thereof to the other parties. Notices required by this Agreement shall be effective if delivered by hand, overnight courier service, facsimile, or U.S. Mail, postage prepaid. Notices shall be deemed received within three (3) days of deposit in the mail if sent by U.S. Mail, upon receipt by the sender of an electronic confirmation if sent by facsimile, upon delivery if hand delivered, and one (1) business day after deposit with any overnight courier service if sent in such manner.
